The Encore Cafe and the PEAK Lunch - In developing our cafe model for the meal program we researched programs nationwide and highlighted as best practices by the National Council on Aging (NCOA) and the American Society on Aging (ASA). By using volunteer wait staff, providing menu options, and offering meal service from 11:30 AM-1:00 PM we have created a cafe restaurant ambiance. This year 1,021 people were served 28,193 meals.

4b (Code:) (Expenses \$ 211,231 including grants of \$) (Revenue \$ 86,685)

Fitness and Health Programing - We offer a variety of exercise classes, programs related to health and wellness, and a variety of wellness screenings. In regards to the fitness classes and fitness room, participants noted reasonable rates, and the adaptations offered for people with differing physical abilities. They state they feel safe in the classes and enjoy exercising with people of their own age group. In addition, they socialize during class and have made new friends because of their participation. People with experience using the fitness room note the availability to work around their own schedules, they feel safe, the room is well maintained, and they are comfortable.

Information & Assistance/Social Service Connections-We have made educating seniors about available benefits one of our highest priorities. We are engaging in a marketing campaign to encourage people to come in for a brief screening to find programs for which they may be eligible. Once we determine probable eligibility, our staff will help with the app. process & appeal process if necessary. We also offer free tax prep. services in partnership with AARP volunteers, financial & legal advice, assistance with rebates, Medicare & healthcare options, & access to other agencies & gov't services. This year 175 people were screened for benefits of which 94 were determined to be eligible for programs for which they were previously unaware. In addition, 72 people are now receiving new/add'l benefits.
